FRANCE MEDIAS MONDE is a dissolved overseas company registered in Cyprus, incorporated in 1970 (about 55 years ago). It has 20 directors / officers on record. Signals for review: a connected person matches a politically exposed person (Councillor of Paris); it shares a director with a failed, near-identically-named company (possible phoenixing).
