SUMMARY

Stadtwerke Münster GmbH is an active company registered in Germany. It has 13 directors / officers on record. It has won 6 public contracts worth €1.2m in EU procurement, 50% of them with a single bidder — a competition red flag. Per GLEIF, it is ultimate parent-consolidated by Stadt Münster. It is the consolidating parent of 1 other LEI-registered entity. Signals for review: a connected person matches a politically exposed person (member of state parliament); it shares a director with a failed, near-identically-named company (possible phoenixing).
