STADE TOULOUSAIN RUGBY is a dissolved Public limited company (SA, directoire) registered in France, incorporated in 1998 (about 28 years ago). It reports 100 employees, has share capital of €3.1m. It has 6 directors / officers on record and 18 shareholders. Its 2025 accounts report revenue of €58.0m, equity of €12.4m, a profit of €160k. Signals for review: it shares a director with a failed, near-identically-named company (possible phoenixing).
