SUMMARY

IMAGERIE MEDICALE ET RADIOTHERAPIE is an active Professional simplified company (SELAS) registered in France, incorporated in 2009 (about 17 years ago). It reports 50 employees, has share capital of €107k. It has 15 directors / officers on record. Its 2024 accounts report revenue of €27.3m, equity of €13.3m, a profit of €5.7m. Signals for review: a connected person matches a politically exposed person (member of the French National Assembly); it shares a director with a failed, near-identically-named company (possible phoenixing).
