## SUMMARY

ATELIER D ARCHITECTURE LOCOS is a dissolved Limited liability company (SARL) registered in France, incorporated in 2015 (about 11 years ago), dissolved in 2023. It has share capital of €2k. It has 1 director / officer on record. A court ordered its judicial liquidation in 2023. Signals for review: a connected person matches a politically exposed person (Q66499541); it shares a director with a failed, near-identically-named company (possible phoenixing); its registered address is shared by 162 companies.
