ABC RE P2 LIMITED is a private company registered in Cyprus, incorporated in 2018 (about 7 years ago). It is in the process of being struck off the register. It has 2 directors / officers on record. Per GLEIF, it is ultimate parent-consolidated by ALPHA ΥΠΗΡΕΣΙΩΝ ΚΑΙ ΣΥΜΜΕΤΟΧΩΝ ΑΝΩΝΥΜΗ ΕΤΑΙΡΕΙΑ. Signals for review: it shares a director with a failed, near-identically-named company (possible phoenixing); its registered address is shared by 336 companies.
